The "Missing Middle:" Delaware's Working Families Can't Afford Child Care but Don't Qualify for State Programs


2024 Eligibility for Purchase of Care by State

A Family of Four Can Make No More Than \$60,000 to Qualify and \$62,400 to Keep Publicly Funded Child Care

If Delaware adopted neighboring states' policies, many more families could access and keep child care benefits

Quit Your Job or Afford Child Care?

Delaware Families in Tough Financial Spot

Basic Survival Budget for 2 adults and 2 children: \$102,397

In Delaware, two working adults with two children would have to make a minimum of \$24.60 an hour each (working 40 hours a week) to afford child care and all other basic expenses (housing, transportation, utilities, food, etc).

If only one adult in the family is working, they would need to make \$44.33 an hour (Delaware minimum wage is currently \$13.25).

Other household expenses

Child care—per child—costs nearly as much as, if not more than, housing and healthcare.



These numbers were calculated for two adults and two children.

The average cost of child care per year per child is \$15,344.

Roughly 10% of married couple median income

Roughly 22% of a single parent's median income.
